



# ASQ:SE and ASQ-3 Screening and Referral Process– Healthcare Provider Edition

All Well Child Visits: Perform Developmental Surveillance

## American Academy of Pediatrics Guidelines:

- Perform Developmental Screenings at 9, 18, and 24 or 30 month well child visits (ASQ-3)
- Perform Autism Specific Screen at 18 and 24 months or when concerns (MCHAT)
- Screen for social & emotional development at any well child visit (ex. ASQ:SE2)

## ASQ:SE 2 Administration Recommendations:

- Complete ASQ:SE questionnaire at 2, 6, 12, 18, 24, 30, 36, 48, and 60 month age intervals.

## ASQ:SE & ASQ-3 Results & Next Steps:

Screening and referral process should be done in partnership with the family, & be based on individual child’s needs.

If family has concerns, please refer to appropriate services, regardless of screening test result.

### Facilitated Referral-

1. Have staff assist parent with making referral
2. Send Information related to screening results to referral source
3. Follow up with referral source to ensure referral received, appointment occurred and to obtain results.
